




1. Lead (Pb), Cadmium (Cd), Chromium (Cr)




Mercury (Hg)



3. Hexavalent Chromium (Cr(VI))




4. Polybrominated Biphenyls (PBBs), Polybrominated Diphenyl Ethers (PBDEs)
