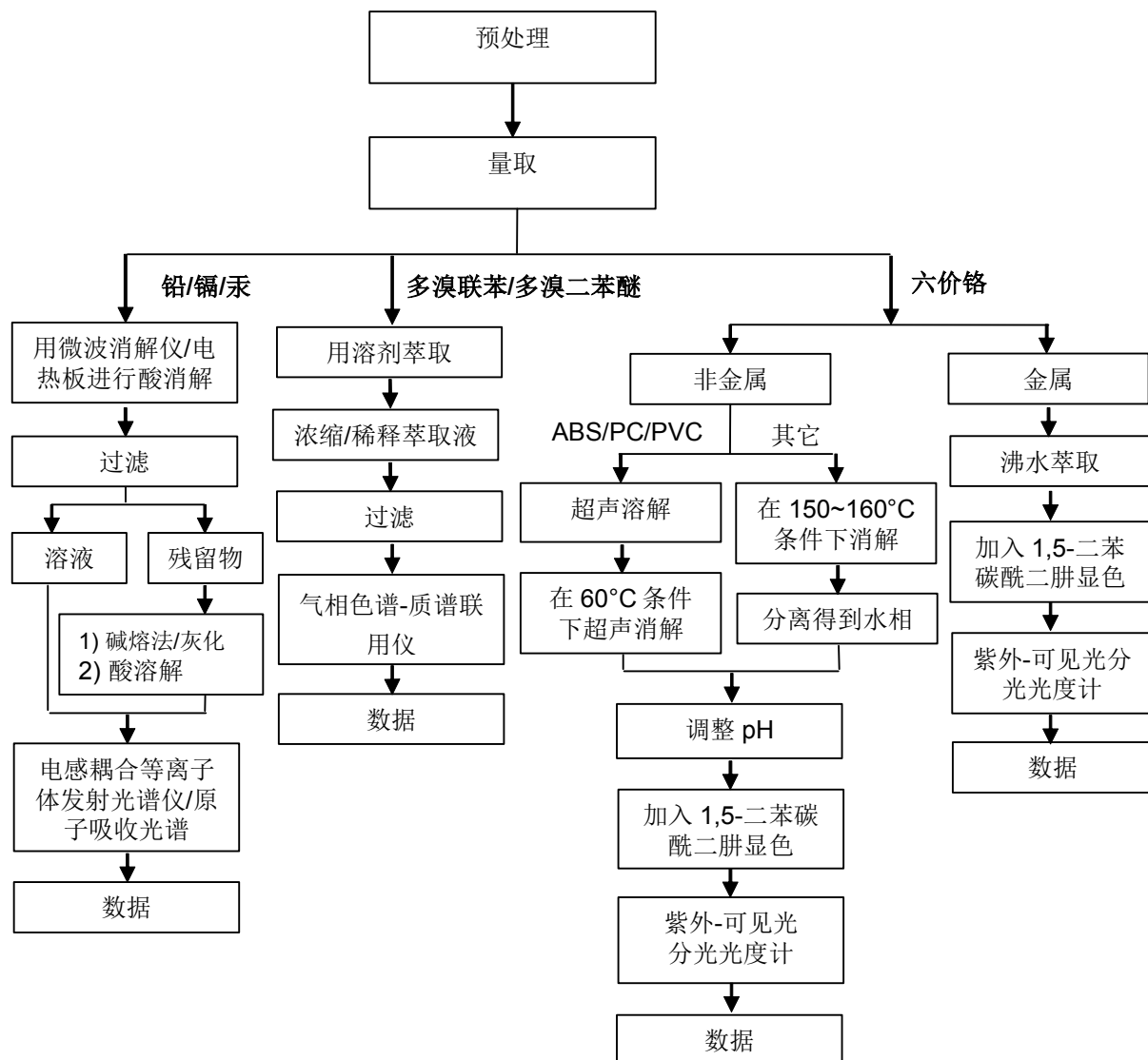

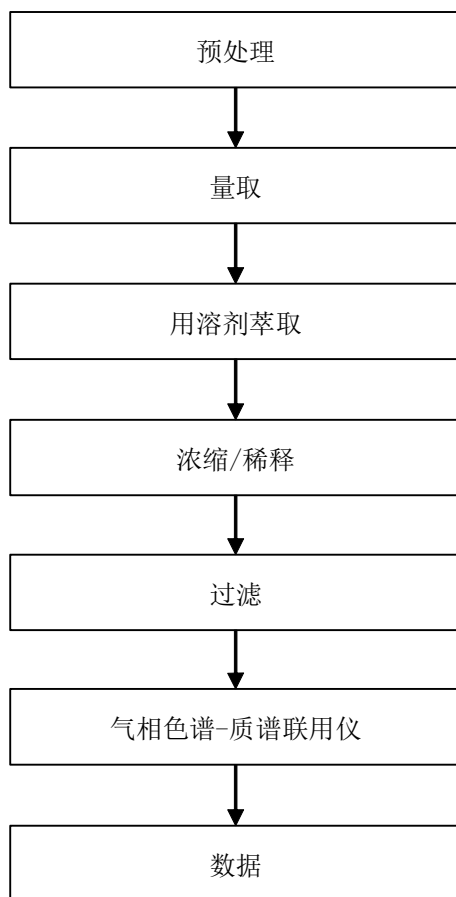
Pb/Cd/Hg/Cr⁶⁺/PBBs/PBDEs 检测流程图
